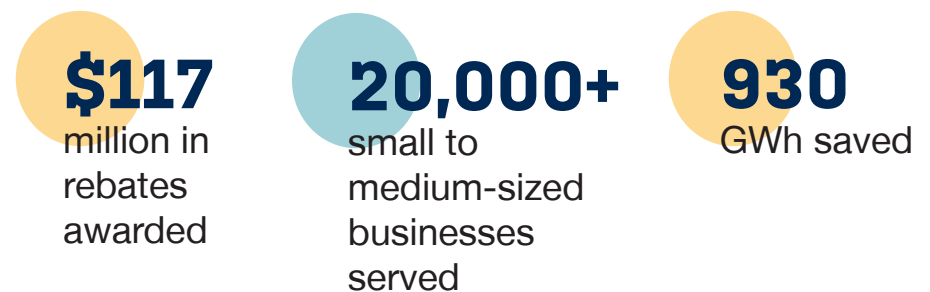
2024 Lighting Bonus Rebates

For a limited time, lighting projects that include LED tubes, fixtures, retrofit kits, and screw-ins are eligible for an additional 25% - 50% in rebates when completed through the One-Stop Efficiency Shop.

Equipment	kW	kWh	Cap*
Non-DLC Fixtures-Kits/High Bay (replacing HID)	\$200	\$0.10	60%
LED Tubes	\$200	\$0.10	75%
Screw-ins/Mogul Screw-ins	\$240	\$0.12	75%
DLC Fixtures-Kits/PLs/Downlights	\$300	\$0.15	75%
Premium DLC Fixtures-Kits	\$375	\$0.1875	75%
High Bay Premium Fixtures - replacing fluorescents**	\$600	\$0.30	75%

*Rebate will not exceed the designated cap as a percentage of the project cost.
 **For qualifying one-for-one replacements only. One-Stop staff will review rebate calculations for non-one-for-one projects.
